Dominican University is a private, Catholic university in River Forest, Illinois with an FTE of almost 3000 students. Is in-person information literacy instruction beneficial?

Abstract:

Rebecca Crown Library conducted an investigation into information literacy instruction comparing student learning outcomes from an automated online tutorial to an in-person class session with an instruction librarian and hope to find students perform better on an information literacy quiz if they had an in-person class session with a librarian.

Motivation for Project:

The motivation for the project was twofold. Similar to many other institutions of higher learning, Dominican University is experiencing a reduction in personnel and budgetary funds. As a result, it became necessary to demonstrate the value of librarians and their role in student success in order to retain librarian positions. Being able to demonstrate in-person instruction sessions as beneficial to student learning would help us advocate for the retention of librarians. Dominican is also in the process of redesigning the undergraduate core curriculum and defining the library role in the information literacy component. Again, if we were able to make a correlation between in-person library instruction and student learning, it would demonstrate the value of librarians and the need for librarian instruction. We also would like to see our students succeed. In-person instruction may lead to greater levels of knowledge and competency for our students.

Partners and stakeholders:

After attending the CARLI Counts workshop our library decided to pursue an instruction related project. As a result, I partnered with our Instruction Services Librarian to develop the project. The Instruction Services Librarian works closely with the English department faculty to define the information literacy component for undergraduate students. The Instruction Services Librarian also serves on the Core Curriculum Committee and plays an integral role in defining and incorporating information literacy in the core curriculum. Stakeholders would be the faculty, students and administrators of Dominican University.

Inquiry Question:

Do students who receive in-person library instruction perform better on an information literacy quiz than students who complete an online tutorial?

Study Participants/Population:

The participants in the study were undergraduate students in English 102 who received an in-person library instruction session and transfer students who completed the information literacy online tutorial.

Method of Data Collection:

The Instruction Services Librarian created an information literacy quiz in Canvas, our Learning Management System (see Appendix). Canvas automatically scores the quiz. All students in English 102 complete the quiz after an in-person session with an instruction librarian. Transfer students have the option to take the quiz or take the quiz after watching an online tutorial, however transfer students do not have the option of an in-person session with a librarian before taking the quiz. The scores of students in English 102 will be compared to the scores of the Transfer students to determine if the students with the in-person instruction did better overall on the test than the transfer students who had the online tutorial.

Findings/Use of Findings:

English 102 is a course offered in the Spring semester. The project is set to start in Spring 2020. We will not have any findings to report until May of 2020.

Next Steps and Other Results:

As we have yet to complete this project, we have not thought much about the next steps. The next steps are dependent on our findings. If we are able to prove in-person instruction sessions are more beneficial for students, we will then need to present the findings to our various stakeholders. Participating in CARLI Counts has helped us to begin thinking of different ways we can assess our services.

Additional Reflections:

Our project was pretty straight forward and easily manageable. No additional resources needed or expenses to budget for. Just the time spent by the Instruction Services librarian to develop the quiz and coordinate the implementation of the quiz with all the instruction librarians for use in their English 102 classes. We will need time to analyze the data and share our findings. The one issue we did experience was in August 2019, the Instruction Services Librarian left our university for another job opportunity. Luckily, she had already designed the quiz and the Interim Instruction Services Librarian was willing to implement the quiz as previously planned in Spring of 2020 and continue with the project.

Evolving snack trends force hotels to keep up

The hotel minibar used to be guests' main option for snacks while on-property, but fewer hotels are including the units in rooms. In addition, guests have become dissatisfied with the high prices hotels often charge for the candy, chips and other goodies. That snack void has been filled by grab-and-go setups.

While snacking has always been a necessity when it comes to food-and-beverage options at Hilton Worldwide hotels, what guests are looking for has changed, said Jonathan Wilson, low hotel guests to eat dinner at 3:30 or 4 p.m. if it better fits their schedule, or to enjoy lighter eating later in the evening.

Danny Williams, GM of the Wyndham Orlando Resort – International Drive, said he also sees guests who want to make a meal out of snacks.

Coffee still the most popular grab-and-go beverage option

No grab-and-go hotel operation is complete without a selection of beverages for guests to choose from. According to Danny Williams, GM of the Wyndham Orlando Resort – International Drive, coffee is king.

"We have different coffee drinks and they are certainly the most popular item all day long," he said. "The cold coffees and the flavored coffees, those are extremely popular with a wide variety of guests."

The Wyndham Orlando serves Starbucks products, everything from chai tea to espresso.

"Anything you would expect to have at a regular coffee bar we have available at our grab-and-go," Williams said.

Plain coffee also remains popular, and the Wyndham offers a shortcut for those who don't require a specialty brew.

The report also showed that between 2008 and 2016, consumption of gourmet coffee beverages soared from 13 percent to 36 percent among 18-24 year olds, and from 19 percent to 41 percent for those 25-39.

While coffee is the king of grab-and-go beverages, at Magnuson Hotel properties, the most popular selections are bottled water and soda, according to company CEO Thomas Magnuson. Many of the brand's hotels do offer coffee, though, along with cappuccino and juices.

The Wyndham I-Drive also offers juices in its grab-and-go area.

Hilton Worldwide properties offer a variety of beverage options, according to Jonathan Wilson, VP, product innovation and brand services. It's Herb N' Kitchen urban market at Hilton Hotels & Resorts properties offers soda fountain options, wine and craft beer. The company's Hampton by Hilton Treats areas include locally sourced and classic domestic beers and wine offerings.

Hotels that carry Hilton's Canopy by Hilton flag (the first one opened last month in Reykjavik, Iceland), will host complimentary tastings of local craft beer, wines or spirits at the lobby bar, which guests can fit into their grab-and-go plans.

In this guided inquiry, students investigate advantages and disadvantages of genetic engineering by integrating popular fiction into their study of bioethics. What are the effects of artificially created hybrid creatures on characters in "The Hunger Games" and in our society? What are the effects on and basic rights of the organisms themselves given their unnatural entry into the world? What impact might these hybrids have on native species? To consider the consequences of genetically engineered organisms in our own society, students must research current practices and policies, as well as contemporary case studies of genetically engineered organisms. This project would fit well in a biology curriculum, perhaps to conclude a unit on genetic engineering. The driving question is, "If hybrids like those we see in 'The Hunger Games' are possible, what are the bioethical implications of such endeavors in our society?" The project culminates in roundtable presentations addressing all aspects of the scaffolded assessment prompts. The project should take about one week (five 45-minute class periods). The project engages students in learning to articulate well-informed decisions about complex socio-scientific issues. This addresses multiple components of scientific literacy (Sadler, Barab, and Scott 2007) and allows learners to explore the most meaningful connections of science to their lives through topics that require dialogue, discussion, and deliberation. This inquiry-based unit engages high school students in considering the role of bioethics in America's increasing fascination with genetic modification. Illuminating content standards of both biological science and Common Core literacy standards, students will be engaged with developing arguments from evidence and important 21st-century skills such as gathering and assessing information, thinking critically, and communicating among multiple perspectives.
