Topic: Managing references with citation management software

### Objectives:

- LO1: The student will be able to identify an appropriate citation management tool for their personal research use.
- LO2: The student will be able to add sources to a citation management tool.
- LO3: The student will be able to insert in-text citations and a works cited section into a word processing document.

#### Materials:

• Computer lab with access to the internet.

#### Activities:

(10 minutes) Choose a citation management tool

- The librarian will present two citation management freeware tools.
- Students will choose a tool, create an account, and download the desktop application.

# (10 minutes) Add sources to the tool

- With librarian guidance, students will:
  - search for books or articles on a research topic of their choosing, using either the library catalog, an article database, or Google Scholar, and
  - o import at least one citation using one of the methods demonstrated by the librarian (e.g., add a PDF document, use the web importer tool, etc.).

## (10 minutes) Insert citations into a word document

- With librarian guidance, students will:
  - o install the citation management tool's Microsoft Word plugin,
  - o insert an in-text citation,
  - o insert a works cited list, and
  - o change the citation style to one used by their discipline.

### Assessment:

- LO1: The librarian will present software options and engage with each student to ensure they have created an account with one tool of the student's selection.
- LO2: The librarian will engage with each student to ensure they have added one or two sources to their reference management library.
- LO3: The librarian will engage with each student to ensure they have added citations formatted for both in-text use and a works cited list using word processing software. The librarian will ensure students understand how to select an appropriate citation style within the citation management application.

# **ACRL Information Literacy Framework**:

- Information has Value
