- Ease of Use
- Faculty Experience and Perceptions







Purchasing Models and Concerns

- Discusses the numerous models available to purchase or lease streaming media
- **Evaluation of Streaming Video Use**
 - COUNTER Compliant but feedback from faculty and students can better measure their experience and usefulness





Discoverability Issues

- MARC Records Important esp. for packages
 - Vendor supplied Quality Cost
 - Own or Rented Need to update records with new content or remove records when rental period is over
- Discovery Services
- Marketing & Faculty Outreach





Survey of CARLI Members

- 66 Libraries Responded
- Number of Video titles Ranged from 6 to over 20,000 with most in the Thousands.
- License question helped inform the section on what to look for in agreements. 21 answers with 11 having no licensing issues

- Most provide usage stats but this varied by vendor/provider
- Evaluate Use 21 Answered with most either not reviewed due to newness and/or relied on feedback from faculty/students
- In-House Conversion and Streaming Only 10 Libraries with rights mostly purchased from DVD vendor








Does your library participate in the CARLI Alexander Street streaming video package purchased for Governing member libraries by CARLI?


Does your library license or purchase access to any other streaming video content?







Why not? (additional purchase/lease)






Do you primarily subscribe to or purchase content?



How long have you been licensing/purchasing streaming video content?




How do faculty and students discover the streaming video content? (Check all that apply)


